ORDER

THIS MOTION, made by Grant Thornton Limited in its capacity as Court-Appointed Receiver and Manager of 1299746 Ontario Inc. o/a Compuquest2000 ("Compuquest") and 2252709 Ontario Inc. 4. **THIS COURT ORDERS** that the Receiver's Preference Motion be and is hereby dismissed with prejudice and without costs.
