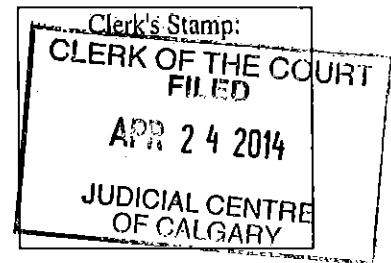

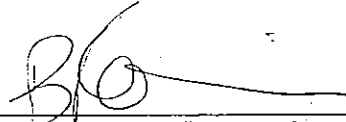
ORDER

UPON THE APPLICATION of Grant Thornton Limited, Receiver of 910234 Alberta Ltd. (the "Receiver"); AND UPON HAVING read the Application filed by Theresa Calmusky, Gary Calmusky and Mary Calmusky (collectively referred to as the "Calmuskys") on January 31, 2014, the Application filed by the Receiver on February 25, 2014, the Ninth Report of the Receiver dated February 24, 2014 (the "Ninth Report"), the Affidavits of Simone Assailly sworn January 31, 2014, the Affidavit of Theresa Calmusky sworn March 13, 2014, the Transcripts from the Questioning of Simone Assailly and Theresa Calmusky; AND UPON considering the written and oral submissions of counsel for the parties;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. The Applications of the Receiver and the Calmuskys are dismissed.

2. The Receiver shall, within two (2) months of the date of this Order, advise counsel for the Calmuskys and the Court as to whether any damages will be sought arising from the stay of proceedings granted by the Court of Appeal on October 15, 2013. Should the Receiver advise that no damages are sought, counsel for the Calmuskys shall be at liberty to release the sum of \$45,000.00 held in its trust account, previously held as security for damages, to pay its fees and disbursements.
3. The parties shall bear their own costs of the Applications.



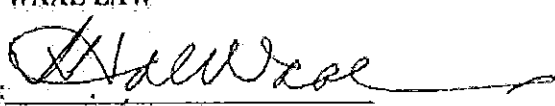
