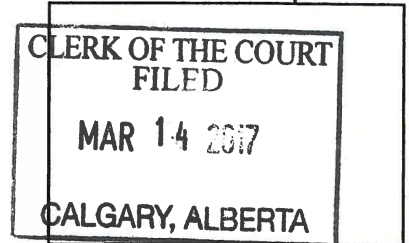

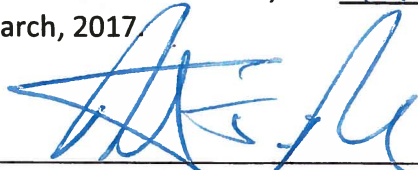
AFFIDAVIT OF SERVICE OF HELEN BOWKER SWORN MARCH 14, 2017

I, Helen Bowker, of Calgary, Alberta, MAKE OATH AND SWEAR:

1. I am employed as a Legal Assistant with the Alberta Energy Regulator ("AER") and as such have direct personal knowledge of the matters herein deposed to except where stated to be based upon information, in which case, I do verily believe such matters to be true.
2. I understand that on Friday, March 10, 2017, counsel for the AER, Jensen Shawa Solomon Duguid Hawkes LLP, delivered by email a filed copy of the AER's Statement of Claim dated March 10, 2017 in the above action to Ms. Bonnie Roberts Jones of Groia & Company.

3. I am aware that Ms. Roberts Jones acts as counsel for Lexin Resources Ltd. ("Lexin") in relation to several other matters before both the AER and the Courts.
4. I understand that on Saturday, March 11, 2017, the AER delivered, by email, an unfilled copy of the Affidavit of Ms. Laura Chant, sworn March 11, 2017, to Ms. Roberts Jones.
5. I understand that on March 12, 2017 that Groia & Company advised that it was unable to confirm that it was acting for Lexin in this matter. I further understand that on March 13, 2017, Groia & Company confirmed it does act for Lexin in relation to this matter.
