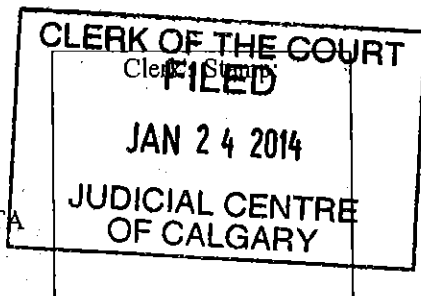

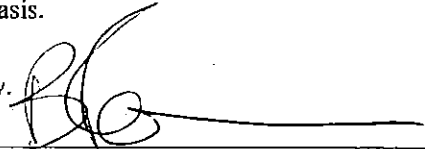
ORDER

UPON THE APPLICATION of Grant Thornton Limited, Receiver of 910234 Alberta Ltd. (the "Receiver"); AND UPON THE ORDER granted on November 6, 2013, by the Honourable Mr. Justice G. C. Hawco, (the "November 6 Order") adjourning the Application heard to December 10, 2013; AND UPON reviewing the Affidavit of Randy Calmusky sworn and filed November 27, 2013; AND UPON HEARING counsel for the Receiver and all other interested parties present;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. The Application of the Receiver heard on October 28, 2013 (as adjourned to November 6, 2013, November 21, 2013 and December 10, 2013) is now adjourned to an Application to be heard on January 13, 2014, peremptory on Randy Calmusky.
2. The following steps to be taken prior to the Application:

Failure to comply with this step will result in the Application proceeding during the week of December 16, 2013, at a date and time to be arranged with Madam Justice B. E. C. Romaine;
- 3. Costs of the adjournment application shall be paid by Randy Calmusky to the Receiver, Harry Chupik and Sarah Lindquist on a solicitor and client basis.
 - 4. This Order may be approved via fax or electronic copy.



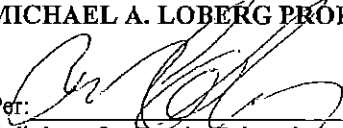

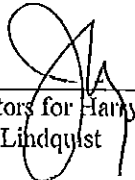
