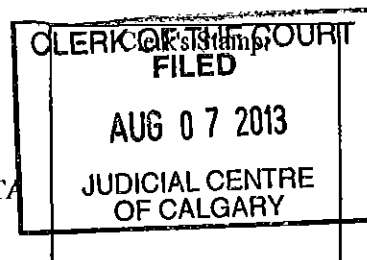

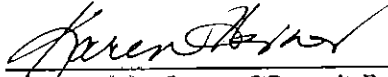

IT IS HEREBY ORDERED AND DECLARED THAT:

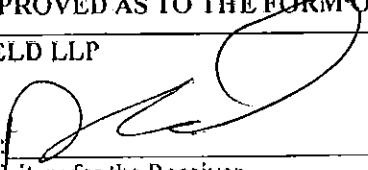
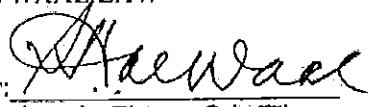
1. The time for service of the Application and all materials in support is hereby abridged to the date of actual service and service is hereby deemed good and sufficient on all required parties.

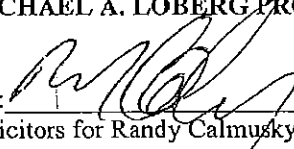

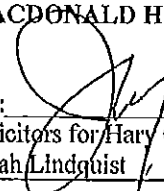
