UPON THE APPLICATION of Alexander (Sandy) Soutzo and Section23 Developments Ltd. (collectively, the "**Landowners**") for an Order declaring that any stay of proceedings in the Receivership Order granted by the Honourable Justice Jeffrey on March 21, 2017 (the "**Receivership Order**") does not operate to stay the Landowners' application to the Alberta Energy Regulator ("**AER**") filed on March 14, 2017 (the "**AER Application**"), or in the alternative for an Order lifting any stay of proceedings in the Receivership Order for the purpose of permitting the Landowners to proceed with their AER Application; AND UPON having read the Affidavit of Chris Plosz, sworn on May 29, 2017; AND UPON being advised that the Receiver is not taking a position with respect to the Application; AND UPON hearing the submissions of counsel for the Landowners and other interested parties;

IT IS HEREBY ORDERED THAT:

1. Service of this Application is deemed good and sufficient and further service thereof is hereby dispensed with.

2. Any stay of proceedings in the Receivership Order does not operate to stay the Landowners' AER Application and no leave of this Honourable Court is required to allow the Landowners to proceed with their AER Application or for the AER to deal with the AER Application.
