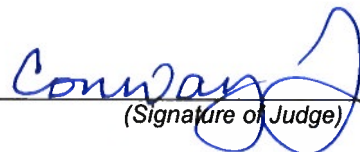

ORDER

THIS MOTION, made by Mr. Gary Wayne Bodimeade ("Mr. Bodimeade") for, among other things, an Order requiring Grant Thornton Limited (the "Receiver") to permanently expunge any materials filed with the Court or uploaded on the Receiver's website that disclose the fact of Mr. Bodimeade's guilty plea to the charge of laundering the proceeds of crime contrary to the Criminal Code, the Probation Order of the Honourable Mr. Justice Sutherland dated September 12, 2006 and the fact of Mr. Bodimeade's discharge, and various ancillary relief was heard this day at the Court House, 330 University Avenue, 8th Floor, Toronto, Ontario.
