1. Grant Thornton Limited was appointed as receiver (the “Receiver”) of the property, assets, and undertakings of Bionx Canada Inc. (“Bionx” or the “Debtor”) pursuant to a court order dated February 27, 2018 (the “Receivership Order”). 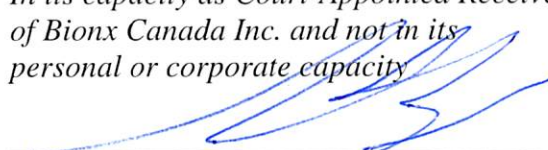
