**ORDER GRANTING DEBTOR'S

ORDERED that Debtors' counsel shall serve a copy of this Order and Notice of Virtual Hearing by the method or methods (phone call, electronic mail, fax, courier, etc.) that will provide expeditious notice and service to the Debtors, any parties with a security interest in assets of any of the Debtors, any parties with pending litigation with any of the Debtors, and any parties that have filed a notice of appearance in this case. Debtors' counsel is further directed to file a certificate of service setting forth the manner and method of all such service prior to the hearing.

Your rights may be affected by the Court's ruling on the Motion. You should read the Motion carefully and discuss the Motion with your attorney, if you have one in this bankruptcy case. (If you do not have an attorney, you may wish to consult one.) If you do not want the Court to grant the relief sought in the pleading or if you want the Court to consider your view, then you and/or your attorney must attend the hearing.
