ORDER GRANTING MOTION TO EXTEND STAY

THIS MATTER came before the Court on an expedited basis on the *Motion to Extend Automatic Stay* (Docket No. 78) (the "Motion") filed by BRON Media Corp. ("BRON"), individually and in its capacity as the Canadian Court-appointed and authorized foreign representative (the "Foreign Representative") for the above captioned Debtors (the "Debtors") on October 12, 2023.

In the Motion, Foreign Representative requests entry of an order recognizing a *Petitioners Order Made After Application* (the "Canadian Order"), entered on October 12, 2023 by the

Supreme Court of British Columbia in Debtors' *Companies' Creditors Arrangement Act* restructuring proceedings.

There being no objection to the relief requested in the Motion, it is hereby:

ORDERED that the Motion is **GRANTED**, such that the Canadian Order will be given full force and effect in these Chapter 15 cases. It is further

ORDERED that counsel for the Foreign Representative shall serve this Order via U.S. First Class mail in accordance with Federal Rule of Bankruptcy Procedure 2002(q) on Debtors, any parties with a security interest in assets of any of the Debtors, any parties with pending litigation with any of the Debtors, and any parties that have filed a notice of appearance in this case. Foreign Representative's counsel shall file a certificate of service regarding the same within three (3) days from entry of this Order.
