AFFIDAVIT OF MEGHAN M. KING

I, Meghan M. King, Solicitor, of the City of St. John's, in the Province of Newfoundland and Labrador, make oath and say as follows:

1. I am a Partner of McInnes Cooper, legal counsel to Grant Thornton Limited, in its capacity as the Court-Appointed Monitor of 92834 Newfoundland and Labrador Inc. As such, I have knowledge of the matters hereinafter deposed except where stated to be upon information in which case I do verily believe such information to be true.
2. This affidavit is made in support of the Monitor's motion, among other things, to approve the accounts of the Monitor and the Monitor's legal counsel for fees and disbursements incurred during the period of March 1, 2022 to August 31, 2023.
3. Attached hereto as **Exhibit “A”** to this affidavit are detailed statements of account setting out the fees and disbursements of McInnes Cooper incurred in its role as legal counsel to the Monitor from March 1, 2022 to August 31, 2023, in the total amount of \$339,823.28 in fees, \$5,147.84 in expenses, with HST for a total of \$344,971.12 and such is summarized at **Exhibit “B”** to this my affidavit. The average hourly rate reflected on the statements of account is \$364.45

4. Given the complexity of the matter as outlined in the Tenth Report of the Monitor, the various legal issues, and the delays and failure of the first successful bidder to complete the purchase of CFI, I believe that the hourly rates and the total amount of fees incurred are reasonable and comparable for insolvency files of this nature.

5. This affidavit is sworn in connection with the approval of the fees and disbursements of McInnes Cooper and for no other purpose.

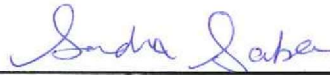
