1. the appeal is withdrawn on consent of Bridging and Box L;



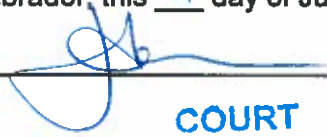

(b) The sum of CAD\$113,078.05 shall be paid to Stewart McKelvey, as solicitors for Bridging, by cheque payable to "Stewart McKelvey in Trust".
