THE RECEIVER HEREBY GIVES NOTICE AND DECLARES THAT:

1. On the 28th day of May, 2024, upon application by Grant Thornton limited (“**GTL**”) in its capacity as the former Court-appointed receiver, GTL was reappointed as Receiver and Manager, without security (the “**Receiver**”) pursuant to section 243(1) of the *Bankruptcy and Insolvency Act*, RSC 1985 B-3, (the “**BIA**”), and section 13(2) of the *Judicature Act*, RSA 2000, c J-12, as amended, over the current and future assets, undertakings, and properties of Lexin Resources Ltd., 1051393 B.C. Ltd., 0989 Resource Partnership, LR Processing Ltd., and LR Processing Partnership (collectively, the “**Lexin Group**”).
2. GTL had been the Receiver in the receivership proceedings of the Lexin Group (the “**Proceedings**”) until its discharge on September 11, 2020. The Proceedings were revived and GTL reappointed Receiver by the Court of King’s Bench of Alberta, pursuant to an Order (the “**Revival Order**”) pronounced on May 28, 2024. 3. The Proceedings have been revived and the Receiver reappointed to address the below potential assets of the estate. The Receiver has not taken possession of the listed assets at this time. Additionally, the Receiver holds \$681,372.40 in trust from prior realizations in the Proceedings.

 - a. Bring an application with respect to the Land Proceeds pursuant to the *Unclaimed Personal Property and Vested Property Act*; and
