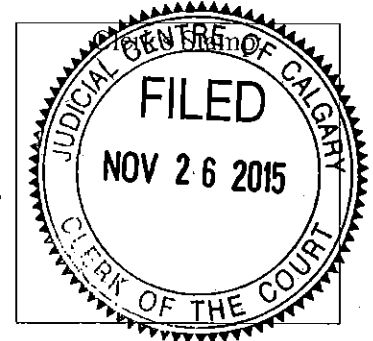

ORDER

UPON THE APPLICATION of Grant Thornton Limited, Receiver of 910234 Alberta Ltd. (the "Receiver"); AND UPON HAVING read the Application filed by the Receiver on November 16, 2015 and the Receiver's Twelfth Report dated November 13, 2015 (the "Twelfth Report"), filed; AND UPON being referred to the documents outlined in the said Application filed by the Receiver; AND UPON HEARING counsel for the Receiver and all other interested parties present;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. The time for service of the Application and all materials in support is hereby abridged to the date of actual service and service is hereby deemed good and sufficient.
2. The Receiver's Statement of Receipt and Disbursements for the period ending November 4, 2015 as outlined in the Twelfth Report is hereby approved.

3. The professional fees and disbursements of the Receiver and the professional fees and disbursements of the Receiver's legal counsel as reflected in the Statement of Receipts and Disbursements outlined in the Twelfth Report is hereby approved.
4. The actions of the Receiver as outlined in the Twelfth Report is hereby approved.
5. The interim distribution of the funds described in the Twelfth Report of the Receiver of up to \$1.5 million is hereby approved.
6. The Registrar of the North and South Alberta Land Registration District shall, notwithstanding s. 191(1) of the *Land Titles Act* of Alberta, R.S.A. 2000, c. L-4 (Alberta), as amended, discharge the Ex-Parte Attachment Order granted by the Honourable Justice K. D. 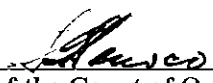
